# Investment objective & strategy

To achieve long-term capital growth through equity or equity related investments predominantly in the stock markets of India. The Fund will also invest in companies traded in other markets where a significant proportion of growth in their underlying business is set to derive from India.

The Fund offers access to the equity market of one of the largest and the fastest-growing economies in the world. Our investment approach results in a concentrated and high conviction portfolio of stocks benefitting from the India growth opportunity. We are long term investors and focus on quality at a management, promoter and franchise level in companies offering valuations with a favourable risk-reward balance that exhibit superior compounding potential over time.

# Commentary

- Over the last month, Indian equities have outperformed the S&P500 (13.7%) and China (4%) with a 14.4% return in local currency. However, on a YTD basis, US and Chinese equities are outperforming global markets with single digit negative returns of -9% and -6%. Comparatively, other Asian and European markets have corrected in the range of 12% to 21% on a YTD basis.
- On a P/B valuation perspective, Indian equities seem to be cheaper than US equities. India trades at approximately 2.3x, while the S&P500 trades at 3.1x as on April 30, 2020.
- The Fund has performed in line with MSCI India on a YTD basis, with a -20% return in USD. Since inception in January 2014 (Share Class I USD), the Fund continues to maintain an alpha with 6.02% p.a. vs the MSCI India at 4.19%.
- Broadly, the fund is overweight on financials, healthcare, consumer discretionary and industrials compared to the MSCI India index. Consumer staples and energy are largely the underweight sectors.


